# TERMS AND CONDITIONS

1. Terms and conditions of PAYMENT: Terms are NET 30 Days from date of invoice. In the event that it becomes necessary for ARK LIGHTING to file suit to enforce payment of past due amounts, such suit may be brought in Los Angeles and shall be entitled to attorney fees, collection fees, court costs and interest at 18% per annum, or such other legal maximum rate as is allowed in the State of California, on all amounts found to be due and payable. All purchases are deemed made and payment is due at principal place of business of ARK LIGHTING in Los Angeles, California. It is expressly stipulated that any action, other than foreclosure of lien, may be filed in L.A. County.
2. Interest may accrue on unpaid invoices from the 30th day following delivery of shipment. Interest will accrue at the rate of 18% ANNUAL PERCENTAGE RATE, or 1.50% per month.
3. Buyer acknowledges, guarantees and warrants to ARK LIGHTING that the person signing this contract, any future invoices evidencing materials purchased pursuant to the contract, any Financing Statement, any Bill of Lading, delivery ticket or receipt, is a person authorized to sign their name. In the event the buyers wishes to specify or limit persons in authority to order and purchase on their behalf, it shall be the Buyers responsibility to submit and update such a list.
4. Financial statements, credit information, information supplied by the Buyers or by any others on the buyers behalf, or agreements are a part of this contract. Any false or misleading information constitutes a fraudulent misrepresentation.
5. All promises of shipment of delivery are approximated as closely as possible by Seller, but are subject to weather conditions, fires, strikes, disputes with workmen, floods, accidents, embargoes, delays in transportation, mechanical breakdowns, shortages of fuel, water, or other materials, shortages of labor, action by any government agency, and to any other cause beyond reasonable control of ARK LIGHTING. in no event will Seller assume any responsibility for delays in shipments or delivery.
6. The acceptance of any individual order and terms of payment on all sales and orders are subject to approval by Credit Department of ARK LIGHTING.
7. Buyers grants to and ARK LIGHTING retains a security interest, pursuant to California Uniform Commercial Code. In the building supplies, and in all additions and accessions here to and title to all said building supplies shall not pass to Buyers until all sums hereunder are fully paid. Buyers assumes all risk of loss or damages to said building supplies. All parties agree that this document constitutes a security agreement. This security agreement covers all property of the same character as that covered by this agreement which buyers may hereafter acquire at any time until the termination of this agreement.
8. All sales are made pursuant to these conditions an all orders are received with understanding that they are placed under these conditions.
